⁵ The letter must clearly include a certification from the CEO of the parent organization stating that the applicant organization is covered by the parent organization's IRS Form 990 (if applicable; the IRS Form 990 is not necessary for organizations that are churches).

⁶ The letter must clearly include a certification from the CEO of the parent organization stating that the applicant organization is covered by the parent organization's audited (or reviewed, as applicable) financial statements.

⁷ The CEO must be signed by the CEO or CEO-equivalent of the organization. For chapters of the American National Red Cross (which is chartered by Congress), the certificate (i.e. CEO letter) is signed by the Assistant Corporate Secretary.
